Lee reviewed some statistics from the 2011 racing year:

V. Question and Answer Session

Lee opened the meeting for questions.

Lynda Oleksuk indicated she agreed with theory behind the multibreed proposal - to keep the
class functioning. She asked if the Board was going to consider other alternatives to keep the
class alive.

Lee said that the Board has started discussing other alternatives, but welcomed outside suggestions. He said that the clear message from delegates seems to be not to alter the point system. The Board is open to suggestions and is researching possible options. The Board feels it is important to preserve our historical classes.

• Geoff Brown inquired whether the Board has considered holding the CanAm event in Canada? The issue has been researched for several years. Lee indicated that it's a relatively complicated question because the site must be central enough to draw the population needed for the event and at the same time be large enough to accommodate the event within a reasonable price structure. Lee said that we are open minded to moving the event, but this year it will remain in Indianapolis. He also recognized that competitors like returning to the same site because they know the resources, such as hotels, site set
