- <u>Electronic submission of results</u> when results are submitted electronically, clubs are no longer required to submit hard copies of timesheets, but must retain the documents for at least one year in case of any discrepancies. NAFA® will no longer authorize use of its UPS account for shipping of results.
- <u>Judge of Year Award</u> new award created for approved & supervising judges, nominations due July 31, Board will narrow the list to no more than 5 finalists for delegate vote.

- Amendment to Performance Team rules amended to clarify that dogs may not be double listed on a performance team in limited tournaments where double running would not be permitted.
- Recording heights on time sheets -- Failure to record a height on a C.2 timesheet alone
 does not trigger the penalty specified in Section 7.6 and does not require forfeiting of the
 heats. But a team who does not record a height on a C.2 form and fails a height
 challenge will be presumed to have been jumping the incorrect height in all preceding
 heats.
- <u>Stopping racing in inclement weather</u> clarified that under Chapter 2(e), judges have the authority to stop racing for anything that affects the safety and wellbeing of the dogs and exhibitors, including inclement weather.
- <u>Alternate materials for 1 and 2 inch slats</u> denied request for use of Azek® as a comparable material for use in 1 and 2 inch slats.
