#### Gonzo

For Clyde Moore Hall of Fame

Gonzo definitely lived up to his name. Now retired from flyball, Gonzo was one of the first Border Collies in Region 3 to be truly motivated and driven for this sport. Owned by John Frey, Gonzo first started running flyball with the Flying Red Rangers (now Dynomutts) in 1989. He ran "all out" on whatever equipment was put in front of him. He first ran on Sure Shot boxes back when line judges tried to monitor passes with the naked eye, and ended up running on the mod-

ern two hole boxes we see today. Gonzo helped his team to run in the 17 second range over 13" jumps and claim two Regional wins in 1998 & 1999, when he was over 10 years old. Over the years, Gonzo helped many dogs on his team attain titles that they may not have otherwise reached. Gonzo ran mostly as an untiring start dog, but could run anywhere in the line-up that he was needed. He was one of the first handful of dogs in Region 3 to earn the Flyball Grand Champion title. It never took long for the newcomers to the sport to hear about Gonzo. If you were lucky enough to have witnessed this red and white, indestructible blur run; you would understand why he is being nominated for the Hall of Fame. Gonzo didn't just play flyball, he was flyball.

# **Higgins**

For Clyde Moore Hall of Fame

Big in attitude, determination and drive, attending every tournament in Region #6 since 1992, Higgins has run consistently for his team and kept the jump height low. Listed as the #13 point earner out of almost 9,000 dogs, and having earned over 40,000 points, Higgins has led a very distinguished flyball career. Beginning as Quantum Leap's only height dog, Higgins then became the sole height dog for over 5 years on the 5 time Region #6 Championship team – Touch N Go. Small in stature but big in deed, at 9 years old he is still a significant force in bringing his team to victory.

As the first dog to earn an Onyx and FGDCh in his Region, Higgins has become an icon of what the term "height dog" really means. His speed was recognized at the 1994 Texas Shoot Out when he was awarded the "Fastest Lightweight Dog" as well as the "Fastest Jack Russell Terrier". Higgins' worth was also acknowledged by the participants of the 1995 Jumps N Jackpots tournament, when he was voted "Most Valuable Dog" Being inducted into the Clyde Moore Hall of Fame would give him the formal recognition by his peers that is so well deserved.

# Spitfire's Classy Lassie (Kelly)

Look at that little black dog go!!

Kelly, a retired Staffordshire Bull Terrier and former foundation jump height dog, began her flyball career in May 1988. From the commencement of the Tailspinners Flyball Team, she ran on the "A" team and on our #1 Four-Breed team. Willingly double running was how she spent much of her career.

Until the early 1990's, she was the fastest jump height dog within the Tailspinner's region of Southern Ontario. Because of her athleticism and drive, the more she played flyball the more she poured it on. This little Staffie never tired out.

Our little black dog has an impressive collection of flyball achievements. She became the first Staffordshire Bull Terrier Breed Champion, Onyx, and Flyball Grand Champion award winner with NAFA. 1995 saw Kelly selected to the Four-Breed Dream Team at a tournament in Camp Borden, Ontario. Last year at the Novi Michigan tournament she was elected to the All Century Flyball Team.

Kelly has been a part of the North American Flyball Association throughout its growth and evolution and as such it would be a great honour to have her elected to the Hall of Fame

At 13 years of age, Spitfire's Classy Lassie has lived well up to her name.

He was an integral member of our "A" team for many years and now even in his senior years, is an active member of our "B" team. Sam was the 8<sup>th</sup> dog to earn Onyx status and also the 8<sup>th</sup> dog to earn his Flyball Grand Champion title. Sam has been an ambassador to the sport of flyball, participating in tournaments and demonstrations from Long Island to Los Angeles, and

Puerto Rico to Calgary. Sam has been kind enough over the years to allow Sue to "start" him – so she believes – Sam knows otherwise. His beloved handler is only a technicality. Sam always lines himself up and waits only for someone to say the word "go" before he's off in a flash. Please consider Sam for nomination into the Hall of Fame based on his longevity in the sport, unique and quirky personality, and for all that he has contributed into making flyball the sport it is today.

#### Wyn

For Clyde Moore Hall of Fame

 $\underline{WYN}$  (Gaelic for "faithful friend") 7/27/85 - 8/25/98

I wish to nominate Wyn for the Hall of Fame. Wyn played flyball from puppyhood until the age of 121/2 years. As the height/start dog for Front Runners "A" team, she competed in 47 tournaments, all in the "Championship" Division from April 1986 to May 1992. During this time, Front Runners was ranked among the top 5 teams in North America. Wyn was the first dog ever registered with NAFA, and the first dog to receive the FD, FDX and FDCH title certificates. After a move to North Carolina in 1992, Wyn became the height/Start dog for the newly formed Blockaded Runners, and helped introduce Flyball to this area. She competed in the first Flyball tournament in North Carolina in 1996. Wyn, a BC, owned and loved by Mike Randall, was truly a pioneer in the sport of Flyball. She had notoriety, longevity, and unbelievable team value to 2 different flyball teams. Although her name may not be recognized by those newly participating in the sport, I hope the "oldies" in flyball will remember her wonderful tri-colored face, tell a few "in the old days stories", and vote Wyn into the Clyde Moore Hall of Fame, where she truly belongs.
