The Board of Director's has established a new Standing Committee -- The Disciplinary Committee. Brett has appointed himself, Terri May and I to committee positions. The purpose/criteria of this committee is to:

- 1. Perform all preliminary disciplinary functions for the Board while the Board is not in session;
- 2. Handle all complaints in accordance with the current NAFA guidelines concerning discipline;
- 3. Investigate claims and accumulate information;
- 4. Hear initial reports, research the issues, interview involved parties and their witnesses and provide a complete report to the Board at the next scheduled Director's meeting: and
- 5. Recommend immediate action to the Executive Director. The Executive Director is able to enact temporary disciplinary measures until the findings of the committee and decision of the Board can be completed.

With the establishment of this committee, the Board will be able to immediately begin investigations and provide the Board with more accurate and timely information when deciding to proceed with a full hear-

I hope that the Committee will rarely convene, but when the need arises, we will be there.

Board Meeting & Annual General Meeting 16 & 17 November, 2002

Board Members Present: Alan Weiner, Val Culpin, Judy Hagan, Ule James, Robin Marion, Terri May, Sue Rogers (via telephone), Dale Smith, and Brett Williams. The Executive Director, Steve McAvoy was also present.

Meeting call to order at 7:35 a.m. by Alan.

Brett made the motion to accept the minutes from the past teleconferences Terri seconded. The motion carried unanimously.

**Financial report – Dale -** Val suggested the NAFA get a business plan put together with five year goals and a budget process put together. We will need some clear long-range goals as a starting point for this.

**ED Report** – **Steve** - Steve thanked our two Board members who are leaving this year due to term limits. We've had a dramatic drop this year in the number of dogs excused. We've had a dramatic increase in the number of confrontations between judges and participants. Judges should be reminded of proper authority and what they can/should do in these circumstances. This sport should remain a family event – in some cases its becoming too serious. Steve advocated a disciplinary committee to handle some of this discipline outside the

Board – suggested the ED, Chairman, and a few others. There is no reason we can't host a NAFA champion tournament without giving travel money. Good financial state – we should focus on additional EJS and perhaps staff and office space. Steve's staff has done an excellent job getting things processed and out. We continue to need NAFA News articles from the various committees and groups to make it worth distributing. Looking forward to another good year – hopefully with less charges floating around.

**Regulatory Committee** – Still some 4 month rule people trying to sneak some through or not giving enough lead time.

**Judges and Guidelines** – Judges videos will go to every judge that applies. Dale made a motion to allocate \$7.5K to Line, Box judge and Scoring table video. Brett seconded. Motion passes unanimously.

**Marketing and Promotions** – Costa Rica was discussed.

Accupass from John Thomas was approved for warm-ups during a tournament.

Herbert Wagner info from Terri. Contacted a lady from Fresno who ran with Herbert Wagner. She provided some background and photos.

Regional Director Review – Steve would be interested in input from the Board regarding the appointees. Perhaps we should go to annual review.

"In good standing" – A discussion of probation. Ule motioned that a committee be created to clarify "good standing" and the way suspension, probation and other discipline is handled. Alan tabled the matter to Standing Rules committee.

Measuring of dogs – Discussion of pushing of skin on cattle dogs during measuring , pulling the flesh toward the head. Ule feels this changes the measurement of the dog. Some discussion that parting the hair for measuring is similar.

Another measuring of dogs issue regarding unmeasurable dogs. Motion that paragraph (j) be made a subparagraph of (f) under protesting. And paragraph (k) be amended to say that dogs not measureable not be recorded on the measuring sheet made by Ule. No second. Motion by Ule to add to paragraph (m) add handlers will not manipulate the dog in any way, for instance, grabbing/twisting. No Second. Motion by Ule to amend last sentence of paragraph (m) The judge shall allow up to two measurements of which

the lower height shall be selected for the benefit of the dog. No second.

David Demers has completed his qualifications for regular judge. Robin made the motion to approve David, seconded by Terri. Motion passed unanimously.

Adjourned for the day at 6:15pm

Meeting called to order 11/17/01 at 8:35 a.m.

Use of NAFA database for commercial purposes – NAFA does not allow commercial use of its mailing list and cannot allow advertising in NAFA News. Other options were discussed including the website, free advertising in the NAFA News, etc.

Letter from Scott Stein regarding judges emails on judges list. All agreed there was no problem with including their emails in the list on the website and in printed form.

Next meeting discussed February in Vegas. March  $2^{nd}$  and  $3^{rd}$  in Vegas. Brett will coordinate. Our next AGM will be in Winnipeg Nov  $16^{th}$ , 2002 – Robin will coordinate with a corresponding tournament by Allsorts.

Brett makes a motion, Val seconds to include TDs and RDs in abstaining from alcohol for the duration of their duties at a NAFA sanctioned event effective with the adoption of the new rules documents. Passed unanimously.

Steve will remind his RDs that they need to appoint an acting RD for all duties in relation to their tournament (seeding, format approval, day of tournament duties, etc). Discussion continued regarding use of alcohol by line and box judges. There was no appetite to include them.

Brett made a motion, Terri seconded that alcohol be prohibited from the racing ring and the scoring table. Motion passed unanimously.

Dale makes a motion that dogs that are excused and then have no additional complaints for two years have the excusal removed from its record. Motion failed for lack of second. Val made a motion, Brett seconds that a dog who is excused and then participates in 20 weekends of racing have the excusal be removed from their record. Dale, Terri, Val, Brett – Opposed Sue, Robin, Ule, Judy – Alan broke the tie to defeat the motion.

Letter from KAOS Dogsports was read regarding the failure of Canada #1 at their tournament. Dale will respond.

Ule brings the issue of 3 of 5 racing where sometimes a  $6^{th}$  or  $7^{th}$  heat is required. Ule would like to limit 3 of 5 to 5 total heats, allowing for a tie in 3 of 5 format. Ule makes the point that for computerized tournament systems, adding the additional heat causes difficulties. No action.

Wording changes to provisional judging requirements – Val discusses the option of having judging evaluations returned to the judge as opposed to mailed to NAFA with the tournament results. Some evaluations are being lost or not returned in the current process. Discussion moved on to having a TD evaluate all judges at their tournament to provide for a better feedback on judges performance. Brett moves that all judges who get credit for a tournament be evaluated by each TD and the evaluation returned with the tournament results. Dale seconds. For Val, Brett and Dale – opposed Judy, Sue, Ule, Terri, Robin. A new form will be designed that is basically self-mailing that will allow the evaluation to be filled out and sealed and handed back to the judge for return. This will satisfy the confidentiality of the response as well as put the onus of its return back in the judge's hands. Robin will coordinate the new form.

Disciplinary committee – Brett makes a motion that the disciplinary committee become a standing committee. Sue seconded. Motion passed unanimously. The committee will consider all charges brought forward to the Board, gather information and consult all parties in the dispute and investigate the charges. The Committee will make a formal recommendation to the Board on actions for this dispute as well as recommendations to the ED regarding any immediate action required

Use of EJS for exhibition – use of the EJS before, after or during a tournament for non-sanctioned events is still ok as long as its organized by the TD and it is open to all competing Clubs.

Corporate goals – The finance committee will be

tasked with creating a three year vision for NAFA and the resulting business plan that would support these goals.

NAFA Championships – Brett discussed a model that would allow Clubs to submit a proposal to host the NAFA Championship. This would also be the AGM. We would try to have 3 years announced into the future and be working on what is required of proposals for an additional two years. This will be referred to committee – Brett will chair with Val, Terri and Robin as members.

Four month rule – Dale made the motion that once a dog has received an exception to the four month rule, no further exceptions will be granted for 12 months. Terri seconded. Motion passed unanimously.

The Board now moves on to the consideration of changes to the new documents.

Brett made a motion to adopt the Rules of Racing and Corporate Policies and Procedures as currently edited effective January 1<sup>st</sup>, 2002. Terri seconded. Passed unanimously.

Dale makes a motion that the delegate allocations for the 2002 racing year follow the new formula approved by the Board. Seconded by Val. Passed unanimously.

Val made a motion to adjourn at 1:35pm. Robin seconded. Motion passed unanimously.

Steve called the AGM to order at 6:35pm 11/17/01.

Steve thanked the host Club, Hairier Jump Jets and Jan Mayes for hosting the AGM.

Steve introduced the Board members present as well as Sue Rogers who was home ready to have a baby.

Steve introduced the Nominating committee headed by Denise Delaney and dispatched them to count the ballots.

Steve introduced Alan and turned the meeting over to

Alan once again thanked all who coordinated this meeting and recognized Mike Randall for his contributions to Flyball.

Alan moved on to announcing this year's champions.

Alan thanked Steve and Melanie or their contributions in supporting NAFA through some tough years.

Questions on the new EJS, how sturdy, when.

Questions on new EJS for each region, lowering the bottom beam, going to two digits and its effect on ties. Dogs sneaking under the beams, padding the leading edge of the EJS uprights.

Keeping some of the titles in place as the web pages scroll. Able to do more online (sanction tournies, ...) <a href="flyball@flyball.org">flyball@flyball.org</a> needs an auto-echo to say its been received.

Electronic submission of tournament results.

New Rules documents – what are they, when available

Submission of the NAFA logo to awards vendors so its authorized for use on the center of ribbons/rosettes. Since NAFA logo is trademarked, the permission must come from NAFA.

Thought of featuring rescue dogs in some way in sanctioned competition. Flag in the database or some other way of recognizing them.

Ability to use the NAFA logo in embroidery/other high-value items.

Status of PETsMART agreement.

Promotional and judge's videos as well as new line/box/table videos.

Having a city co-sponsor a tournament along with a NAFA Club.

What does PETsMART get out of the agreement.

Digital version of the videos.

NAFA Championship competition.

Differences in best times in various regions – handicapped racing for Champions

Veterans class and a break in jump heights for veteran dogs.

Ability to get more than regular racing (eg multibreed) on ESPN, etc.

Thanks for the Harlem Globetrotters demos – Alan had arranged.

Ability of all teams to be able to compete at a NAFA Champ event – perhaps an unlimited tournament along with the Champ competition.

Region boundaries and how they effect the travel requirements of Clubs – 12 hours to a home tourney or 2 hours to a tourney in the next region

Question about the Tindall video a few years ago that had racing and music – is it still available – check with Sue to see.

New rules schedule and distribution.

300 mile rule – approval of other tournament director.

Regions not aligned on state boundaries.

Problem with a tournament co-hosted by two Clubs

from neighboring states in two different regions. Could the tourney by counted for both regions. Could one day be one region and the other day be another region.

A whole region hosting a tournament in an expensive venue.

Cost of two one-day tournaments.

Finding an existing event to tack on flyball in a great venue.

Foam padded jump tops.

Requirement for each Club to host a tournament every two or three years.

Smaller clubs can get together with others or a larger club to co-host a tournament.
